#### PRINCIPALS REPORT

### Thank you to the Board -

Gavin thanked the Board for working so positively for the good of the children in what has been a very challenging year.

## Ruru Camp -

Gavin gave an overview on the very successful Ruru camp held at Camp Adair.

## Music in-school programme.

Currently, music tutors are funded by MOE. This year the school has not been able to secure a guitar tutor and the violin tutor has indicated the current rate of pay is not tenable. Therefore Gavin proposed parents pay towards the tutorage and the Board top up any difference.

**Recommendation** - Parents will pay \$20.00 per child per term for the in school music lessons. The School Board will top up any additional funding needed.

This recommendation was passed.

## **School Consultant Psychologist**

Laura Taylor - Registered Psychologist - BSocSc(Hons) MAppPsy(BA) PGDipPracPsych (ABA). Laura has previously worked as a child psychologist for the Ministry of Education and had been the consultant Psychologist for the Anxious Parent Group. Gavin proposed the Board consider employing Laura as a consultant for staff working with children with challenging behaviour. He was seeking approval in principle to budget accordingly. The Board agreed to this in principle for budgeting.
